

Instructions to potential donors of medicines and medical devices

On the occasion of emergencies caused by natural disasters, the Ministry of Health of the Republic of Serbia has been contacted by large number of organizations and individuals from home and abroad who want to donate the necessary assistance in drugs and medical devices. Although the Republic of Serbia provides sufficient quantities of drugs and medical devices to ensure health care in the ordinary circumstances, in state of emergency is necessary to provide additional quantities of certain groups of drugs and medical devices, for which needs of the population are increased.

The Ministry of Health announces that in order to protect the health of patients, individual donations in the form of medicines or medical supplies offered by individuals, cannot be accepted, because it is not known how those medicines were purchased and in what conditions they were kept.

All natural and legal persons who wish to donate medicines, medical and other resources that have market authorization in the Republic of Serbia, can make a donation through the manufacturer or wholesales to Central Pharmacy of Clinical Center of Serbia, which continues to allocate and distribute to all health institutions in the Republic of Serbia, on the basis of their expressed needs.

In the case of donations of medicines which do not have the marketing authorization in the Republic of Serbia, import license is subject to the approval of the Medicines and Medical Devices Agency of Serbia, based on the following documents: Certificate of Good Manufacturing Practice (issued by the competent authorities of the EU) and the manufacturer's certificate of analysis of the drug.

Import of medical devices which do not have the marketing authorization shall be subject to the approval of the Medicines and Medical Devices Agency of Serbia, based on the following documents: The Declaration of Conformity, CE certificate and proof that the medical device is marketed in the country of manufacturer.

Approval for the import of medicines and medical devices which do not have the marketing authorization the Agency will issue within 24 hours.

The contract of donation should be concluded with the Central Pharmacy, Clinical Center of Serbia.
